Notice Of Bidding & Review Of Apportionment On The Flint River,
Granrich Branch of #1539

The property which you own in the Flint River, Granrich Branch of #1539 Drainage District will be assessed a share of the construction costs. At the meeting to review the apportionment of benefits, The Drain Commissioner will have tentative apportionments against parcels and municipalities within the drainage district available for review. This meeting will be held:

October 18, 2017 from 9 a.m. to 5:00 p.m.

Please retain the envelope of this notice, as the parcel number on mailing label is necessary in answering questions.

This construction is the result of a petition submitted to me, Genesee County Drain Office on July 10, 2014 to make drainage improvements in this drain district. A public hearing was held with Drainage Board determining there was a necessity for improvements. An Engineer designed plans to resolve this drainage problem and construction bids will be taken on September 29, 2017. Thomas Jones, Engineer, will answer engineering design and construction questions at (810) 732-1590.

Note: Until bids are opened and reviewed estimates cannot be given regarding your assessment. Assessment information will be available on or after October 18, 2017 in person at the above address, over the phone at the above phone number or online at <http://www.gcdcswm.com/Assessment/Assessment.htm>. You will be given until **November 1, 2017** to prepay your assessment, if you wish before we borrow the money and not incur any interest charges. If drain assessments against land that are collected by installment, the land owner may pay them in full with any interest to date at any time and thereby avoid further interest charges. Drain assessments against land will be collected in the same manner as property taxes. i.e. the winter property tax bill.

Weather permitting; construction of this drain will start upon receipt of the borrowed money. My office will assist you in answering questions concerning the Flint River, Granrich Branch of #1539.

The owner of any land in the special assessment district who may feel aggrieved by the apportionment of benefits made by the drain commissioner may, within 10 days after the day of review, appeal therefore by making application to the probate court of Genesee County for the appointment of a board of review and may further appeal from the report of the board of review by application for a writ of certiorari by the circuit court of Genesee County, all as provided in Sections 155 & 161 of the Drain Code (Act 40 of the Public Acts of Michigan, 1956, as amended).
