The purpose of this meeting is to: 1) review and discuss correspondence from the Hubbard Law Firm regarding adequacy of historical rights of way for the current proposed project and take action to initiate drafting of new ones; 2) receive a report on communications with the Saginaw County Road Commission regarding the design of the channel through county road crossings; 3) receive a progress report from Spicer Group and GEI on the design recommendations for restoration of the dikes, tributary drain outlets and Dam Structure No. 4 and give direction; 4) review the status of the various tasks of the engineering services agreement and take any required action; 5) discuss routine maintenance of the structures and dikes and take action to authorize needed work; 6) authorize the payment of any properly presented invoices, drain orders, and/or vouchers; and 7) any other business that may come before the Board.
