The purpose of this meeting is to: 1) receive from bond counsel and take action on a resolution to extend the existing \$800,000 note; 2) receive from bond counsel and take action on a resolution authorizing the issuance of a new note in the amount of \$995,000; 3) receive a report from the Board members regarding the status of full faith and credit resolutions of their county boards of commissioners; 4) discuss with the project engineer and take action on further refinement to the scope of the final design; 5) discuss the status of right of way acquisition and take any required action; 6) receive reports from the board members regarding maintenance work; 7) authorize the payment of any properly presented invoices, drain orders, and/or vouchers; and 8) any other business that may come before the Board.
