The percent of benefit has been and the same is hereby apportioned upon and assessed against (i) the said Governmental Corporations, because of benefits to public health, (ii) the County because of highway benefits and (iii) the State because of highway benefits, and to the several pieces or parcels of land so benefited, by me to be as follows, to wit:
