

TENTATIVE APPORTIONMENT OF BENEFITS

BE IT KNOWN, that I, Jeff Wright, County Drain Commissioner of the County of Genesee, State of Michigan, have this day apportioned to (i) the Townships, Cities, Villages of Genesee County set forth below, (ii) Genesee County for highways under the control of the County and (iii) State of Michigan Department of Transportation for State trunklines, the respective percent which each shall be and hereby is made liable to pay in construction of a certain drain known and designated as

By reason of the benefit to the public health, convenience and welfare, on account thereof and as the means of improving the highways, and that I, the said County Drain Commissioner as aforesaid, have also apportioned to the several pieces or parcels of land liable to be assessed for benefits, by reason of the constructions thereof, and which they shall and hereby are severally made liable to pay, over and above the percent of costs and benefits assessed against the said Governmental Corporations at large, as aforesaid. The percent of benefit has been and the same is hereby apportioned upon and assessed against (i) the said Governmental Corporations, because of benefits to public health, (ii) the County because of highway benefits and (iii) the State because of highway benefits, and to the several pieces or parcels of land so benefited, by me to be as follows, to wit:
